DECLARATION BY INSURED

I/We declare that in the event of a Windstorm the vessel and/or its gear and equipment will be secured in accordance with the arrangements specified herein.

I/We also declare and agree that My/Our absence from the area at the time of the passing of a Windstorm does not relieve Me/Us from My/Our obligation to protect and safeguard the vessel.

I/We understand and agree that any Windstorm deductible included as a condition of insurance shall be applicable to all claims, including Total, Arranged, Compromised or Constructive Total Loss.

I/We also understand and agree the following:

- In the event of loss or damage to the insured vessel arising from a Windstorm, any claim so arising should be subject to a deductible of 200% of the deductible expressed in Declaration Page in the policy, which is also applicable in the event of a total loss. Each Windstorm will have separate deductibles. Deductible percentage is as of the insured value.
- No claim resulting from the effects of a Windstorm will be paid for loss of or damage to bimini or canvas tops, plastic enclosures, awnings, loose deck furnishings, gear and equipment, roller-furled sails, outriggers, non flush mounted or exposed electronics and antennas unless securely stowed inside the vessel or stored in protected premises ashore.
- No claim or expense shall be paid for loss of or damage to any vessel which remains on a swinging mooring.
- In the event of loss or damage to the Insured Yacht, the choice of the repair facilities will be at the discretion of the insurer and no claim or expense for a loss or damage will be paid if you commence the repairs without the company written authorization.
